This program is to provide financial assistance & education support services to students who have lost their parent(s) due to COVID-19 to ensure continuity of their education. Under this scholarship program, students studying in Class 1 to 12 and undergraduate courses will be entitled to receive a scholarship ranging up to INR 60,000 (one-time) to cover their academic expenses and additional value added services such as Mental Wellness Coaching, Career Counselling, Life Skills sessions. Buddy4Study is the implementation partner for this scholarship program.

Eligibility –

- Students who have lost their parent(s) due to the COVID-19 pandemic are eligible.
- Applicants must be studying in Class 1 to 12/undergraduate (general or professional) degree courses.
- Applicants should be enrolled and continuing their education.
- Open for Indian nationals only.

- If all the details are correctly showing on the preview screen, click on 'Submit' to complete the application process.

For Class 1 to 8 students - INR 24,000 | **For Class 9 to 12 students** - INR 30,000

For professional UG courses: INR 60,000 | **For general UG courses:** INR 36,000

NOTE: This is a one-time fixed scholarship amount. It can be utilized only for academic purposes which includes tuition fees, hostel fees, food, internet, books, stationery, online learning, etc.

Documents –

- Mark sheet of the previous class
- A government-issued identity proof (Aadhaar card/voter identity card/driving license/PAN card)
- Current year admission proof (fee receipt/admission letter/institution identity card/ bonafide certificate)
- Crisis document (Death certificate of parent(s))
- Proof of death due to COVID-19 (Hospital receipts, Doctor Prescription, Covid test report, Medical Bills for COVID medication, hospital discharge summary, etc.)
- Bank account details of applicant (or parent)
- Income proof (Non- mandatory) and Photograph
