

## National Law University, Delhi

The National Law University, Delhi established in 2008 by Act No. 1 of 2008 is premier Law University established in the capital city of India. The University invites applications for admission to B.A.LL.B. (Hons.), LL.M. and Ph.D. Programmes for the Academic Year 2019 – 20 commencing from August, 2019.

### Eligibility –

#### B.A.LL.B. (Hons.)- Five-Year Programme

- 12th Pass from CBSE/ ICSE/NIOS /State Board with a minimum aggregate of 50%.
- Those appearing in 10+2 or equivalent exam can also appear for Entrance exam on provisional basis.

#### LL.M. One-Year Programme

- LL.B. or an Equivalent Law Degree with 55% marks (50% in case of SC/ST/ Persons with Disabilities).
- The candidates appearing in final year LL.B. Examination in April/May, 2019 can also apply. A candidate needs to score at least 55% marks in the qualifying degree.

#### Ph.D.-Programme

- LL.M. Degree with 55% Marks or its Equivalent (50% in case of SC/ST/ Persons with Disabilities).

- Fill the application form and read the instructions carefully.
- Pay the Application Fee, payable by various online method only.  
General Candidates: Rs. 3,050/-  
SC/ST/PwD Candidates: Rs. 1,050/-
- Below Poverty Line (BPL) applicants of SC/ST Category are exempted from application fee.

### Other Information –

Admission to B.A.LL.B. (Hons.), LL.M. and Ph.D. Programmes will be through **AILET** to be conducted at Bangalore, Bhopal, Chandigarh, Chennai, Cochin, Cuttack, Delhi, Gandhinagar, Guwahati, Hyderabad, Jaipur, Jammu, Jodhpur, Kolkata, Lucknow, Mumbai, Nagpur, Patna, Raipur, and Varanasi on May 5, 2019(Sunday).

### Note: Scholarship –

- The Ministry of Social Justice and Empowerment, Govt. of India has approved the name of National Law University, Delhi for Central Sector Scholarship Scheme of Top Class Education for Schedule Caste (SC) students. Under this scheme five scholarships per year have been allocated to National Law University, Delhi.
